- 3. Council discussed various other issues for guidance from the Solicitor including the Water Tower engineering fees, recent Borough property damage, and questions about Qualified Purchasing Agent.

The Tax/Water Collector report was presented for October 2015. Motion Davis, seconded Nolan that the report be received and filed. Motion carried.

Upcoming yearly contracts reviewed; Council requested not to renew the Verdi Clock maintenance contract for 2016 due to the 26% increase. Motion Zee, seconded Nolan that the correspondence be received and filed. Motion carried.
