## Elmer Borough Land Use Board Minutes of Board Meeting Thursday, April 7<sup>th</sup>, 2016

The regular meeting of the Elmer Borough Land Use Board was held on Thursday, April 7<sup>th</sup>, 2016, at 6:30 p.m. in the Elmer Borough Hall.

Secretary Dawn Williams read the Open Public Meetings Act Statement.

Present at the meeting were Tammy Collins, Fred Davis, Councilwoman Lynda Davis, Vice-chairman Jay DuBois, John Hagen, Linda Herrmann, David Newkirk, Chairman Lewis Reed, Mayor Joseph Stemberger, and Secretary Dawn Williams. Board Attorney Katie Coleman, Zoning Officer Derek Leary, and Board Engineer Corey Gaskill were also present.

Secretary Dawn Williams announced that she would have a conflict of interest with any application filed by Patrick Fisher, as she owns property within 200 feet of Patrick Fisher. No action was taken.

Vice-chairman Jay DuBois motioned and Fred Davis seconded to adopt the Board Minutes from March 3<sup>rd</sup>, 2016 as presented. The motion was unanimously carried.

Patrick Fisher explained his garage plans to the Board. Zoning Officer Derek Leary added comments regarding the two adjoining lots (the house is situated on one lot and the garage would be built on the other lot). The Elmer Diner may wish to change update its existing sign, maybe incorporating lights. Mayor Joseph Stemberger updated the Board on the sidewalk and curb cut project. Zoning Officer Derek Leary clarified that cars within the Borough should be registered or kept in a garage. The old Carl Harz Furniture building was purchased by a furniture warehouse company. No action was taken.

Mayor Joseph Stemberger welcomed Heather Runyon to join the Land Use Board. Heather Runyon will take the Oath of Allegiance at the next Land Use Board meeting. No action was taken.

Secretary Dawn Williams reminded all members to file their annual financial disclosure statement with the state. No action was taken.
