CALL TO ORDER: A Regular Meeting of the Borough Council convened in the Borough Hall at 7:30 p.m. with Mayor Stemberger presiding.

FLAG SALUTE AND INVOCATION: Invocation was given by Mayor Stemberger, followed by the pledge of allegiance. Mayor Stemberger noted that adequate notice of the meeting was provided pursuant to the Open Public Meetings Act.

ROLL CALL: President Schneider, Council Members Nolan, Richards, Schalick, Zee, and Mayor Stemberger answered to the roll call. Absent: Council Member Davis. Also present were Solicitor Duffield, Chief Financial Officer Strang, and Chief of Police Bryan.

RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER AUTHORIZING AND APPROVING MEMORANDUM OF UNDERSTANDING WITH THE STATE OF NEW JERSEY OFFICE OF EMERGENCY MANAGEMENT

Number 36-16

WHEREAS, the New Jersey Office of Emergency Management, hereinafter referred to as the "NJOEM", on behalf of the State of New Jersey, is the Grantee receiving Federal funding under the FEMA Public Assistance and/or Hazard Mitigation Programs as authorized under the Stafford Act; and

WHEREAS, the NJOEM has the fiduciary duty and responsibility to ensure Federal funds are spent in accordance with the current Guidelines and Regulations; and

WHEREAS, under current information provided, FEMA has determined that the Borough of Elmer is eligible to apply for and/or receive FEMA funding under the Public Assistance and/or Hazard Mitigation Programs, subject to approval of a Project Worksheet for Public Assistance or Application for a Hazard Mitigation Grant; and

WHEREAS, the NJOEM has submitted a Memorandum of Understanding (MOU) for execution by the Borough memorializing the Borough's obligations with respect to the Programs administered by FEMA, as well as the NJOEM.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Elmer, County of Salem and State of New Jersey that the Borough of Elmer does hereby authorize and endorse the submission on the attached Memorandum of Understanding and that the appropriate officials are authorized to endorse and execute the MOU.

- 2. Ordinance for Foreclosures: The Solicitor recommended against changing the existing Vacant and Abandoned Property ordinance to include all properties in foreclosure.
- 3. Grants for Park Trails: Mayor Stemberger presented information about a DEP and a Health and Wellness grant for the Green Acres Park.
- 4. Sidewalk Ordinance: Mayor Stemberger initiated a discussion about the enforcing the existing sidewalk ordinance. A member of the public requested to be permitted to speak.

Motion Zee, second Nolan to reopen the meeting to the public.

Donna Stemberger, 20 Fourth St., commented about the poor condition of many sidewalks in the borough for running and walking and her concern that the sidewalk laws are not being enforced. Council Members discussed various options to revising the current sidewalk code to the version presented last month by Council Member Richards. Richards suggested that the Solicitor present a clean version for introduction at next month's meeting.

Motion Zee, second Nolan to close the meeting to the public.

Water/Street Lights: Zee reported on status of remediation project and funding.

Trash/Recycling/Parks & Playgrounds: Nolan reported on the recycling report and noted that the chipper will be in town on April 14th.
