#### **Borough of Elmer Minutes**

#### February 13, 2019

**CALL TO ORDER:** A Regular Meeting of the Borough Council convened in the Borough Hall at 7:30 p.m. with Council President Schneider presiding.

**FLAG SALUTE AND INVOCATION:** Invocation was given by Councilman Zee, followed by the pledge of allegiance. Council President Schneider noted that adequate notice of the meeting was provided on January 7, 2019 pursuant to the Open Public Meetings Act.

**ROLL CALL:** Council President Lewis Schneider, Council Members Lynda Davis, Cynthia Nolan, Steven Schalick, and James Zee answered to the roll call. Absent were Council Member Richards and Mayor Joseph Stemberger. Also present were Solicitor Brian Duffield, Chief Financial Officer Cynthia Strang, and Clerk Sarah Walker.

**APPROVAL OF MINUTES:** Motion Zee second Nolan to approve the minutes from the Reorganization and Regular Council Meeting held on January 2, 2019, and to dispense with the reading of the minutes. Roll Call: Ayes: Schneider, Davis, Nolan, Schalick, Zee; Nays: None. Absent: Richards. Motion carried.

**COUNCIL VACANCY:** Motion Davis second Zee to accept the resignation of Councilman R. Matthew Richards with regret effective January 31, 2019. Councilman Zee discussed three candidates recommended by the Republican Committee: Bruce Foster, Stanley Orzechowski, and Jennifer Sutton. Motion Zee second Davis to approve Bruce Foster to fill the position of Council Member Richards until the election.

Roll Call: Ayes: Schneider, Davis, Nolan, Schalick, Zee; Nays: None. Absent: Stemberger. Motion carried.

**Swearing in and Oath of Office:** Bruce Foster was administered the oath of office for Borough Council Member by the Clerk, Sarah Walker. Foster took the seat of Richards for the rest of the meeting.

**PUBLIC SESSION:** Motion Zee second Nolan to open the public portion of the meeting. All were in favor and the motion carried.

Tina Fithian Anderson, 409 N. Main St., read a prepared statement about the history of her family and business activities in Elmer and investments to rehabilitate properties in Elmer. She is concerned about a recent Land Use Board decision and wants fairness for their application. Roger Anderson, 409 N. Main St., spoke on the history of the problems working with the town on properties they are rehabilitating and lack of fairness for their application compared to a recent Land Use Board decision. Other members of the audience spoke on behalf of the Anderson's business and rentals and against the town's treatment of the Anderson's: Eric Fogg, LAC resident and Anderson employee, Cynthia Mayer, employee, Jacelyn Ireland, rents from Anderson's in Elmer, Amy (sister to Tina Fithian), George Peacock, and another employee. No action was taken.

Motion Zee second Davis to close the public portion of the meeting. All were in favor and motion carried.

## TAX IDENTIFICATION STATEMENT

#### Number 28-19

**WHEREAS**, The Recycling Enhancement Act, P.L.2007, Chapter 311, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

**WHEREAS**, There is levied upon the owner or operator of every solid waste facility (with certain exceptions) a recycling tax of \$3.00 per ton on all solid waste accepted for disposal or transfer at the solid waste facility.

**WHEREAS**, Whenever a municipality operates a municipal service system for solid waste collection, or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law, the amount of grant monies received by the municipality shall not be less than the annual amount of recycling tax paid by the municipality except that all grant moneys received by the municipality shall be expended only for its recycling program.

**NOW THEREFORE, BE IT RESOLVED** by the Borough of Elmer that the Borough of Elmer hereby certifies a submission of expenditure for taxes paid pursuant to P.L.2007, chapter 311, in 2018 in the amount of \$1951.71. Documentation supporting this submission is available at 120 South Main Street, Elmer, NJ and shall be maintained for no less than five years from this date.

## BOROUGH OF ELMER, COUNTY OF SALEM TONNAGE GRANT APPLICATION RESOLUTION

#### Number 29-19

- **WHEREAS,** The Mandatory Source Separation and Recycling Act, P.L. 1987, c.102, has established a recycling fund from which a tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and
- **WHEREAS,** It is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs;

- WHEREAS, The New Jersey Department of Environmental Protection has promulgated recycling regulations to Implement the Mandatory Source Separation and Recycling Act; and
- **WHEREAS,** The recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and
- WHEREAS, A resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and to indicate the assent of the Mayor and Borough Council to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and
- **WHEREAS,** Such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Borough Council of the Borough of Elmer that the Borough of Elmer hereby endorses the submission of the 2018 recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Cynthia L. Nolan to ensure that the application is properly filed; and

**BE IT FURTHER RESOLVED** that the monies received from the 2018 recycling tonnage grant be deposited in a dedicated Recycling Trust Fund to be used sorely for the purposes of recycling.

**WHEREAS**, these quotes were reviewed and a recommendation made by the President of Council that the quote be awarded to Archer Exteriors, 341 Harding Hwy, Pittsgrove, NJ as per the attached quote in the amount of \$16,248.00;

**3. Water Remediation Project**: Councilman Zee updated Council on the loan/grant opportunity from the Salem County Pollution Control Authority and the following resolution was read by title:

## BOROUGH OF ELMER COUNTY OF SALEM RESOLUTION AUTHORIZING GRANT FUNDS FROM THE POLLUTION CONTROL FINANCING AUTHORITY OF SALEM COUNTY FOR THE BOROUGH OF ELMER REMEDIATION PROJECT Number 35-19

**WHEREAS,** on August 7, 2018, the Borough of Elmer, represented by Elmer Borough Council Member Jim Zee, appeared before the Salem County Pollution Control Financing Authority (PCFA) seeking funding for a remediation project needed within the Borough of Elmer; and

**WHEREAS,** on the above date, Elmer presented to PCFA information regarding an underground storage tank located within the Borough of Elmer, which, upon discovery and notification by the New Jersey Department of Environmental Protection (NJDEP), created contaminated materials which the NJDEP was requiring Elmer to remediate;

**WHEREAS,** to date, Elmer has paid a remediation contractor \$30,000 to begin the remediation project, \$16,000 to the NJDEP for fees associated with the contamination, and anticipates a total project cost for the remediation of \$113,000; and

WHEREAS, in consideration of the above factors, PCFA has determined that it is in the best interest of Elmer, PFCA, the County of Salem, and the residents of both the Borough of Elmer and thus by extension, the County of Salem to provide a grant to the Borough of Elmer in the amount of \$22,600 and a loan in the amount of \$90,400 at an interest rate equal to the federal funds rate at the time of the loan closing less 0.2% for a period of three years; and

**WHEREAS**, the Borough of Elmer has decided to accept the grant amount of \$22,600 and decline the loan amount of \$90,400 in order to pursue other financing; and

**WHEREAS**, it is in the best interests of the residents of the Borough of Elmer that the Borough Council accept the grant for the purposes as stated above.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Borough Council, Borough of Elmer, that the Grant is hereby ratified and the Mayor and Clerk are hereby authorized to execute the Grant Agreement.
