EMERGENCY APPROPRIATION RESOLUTION (N.J.S.A. 40A:4-48)

WHEREAS, an emergency has arisen with respect to the need to provide for matching funds for the fiscal year 2014 – 2015 **Municipal Alliance on Alcoholism and Drug Abuse** grant and no adequate provision was made in the 2014 budget for the aforesaid purpose, and

- 2. That said emergency shall be provided in full in the 2015 budget.
- 3. That the Chief Financial Officer has certified that the expenditures to be financed through this resolution are related to the aforementioned emergency.
- 4. That two certified copies of this resolution be filed with the Director of the Division of Local Government Services.

RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION (N.J.S.A. 40A:4-87)

SECTION 3a

BE IT FURTHER RESOLVED that the sum of \$1,044.39 be anticipated from the proceeds of an emergency resolution theretofore adopted providing for the municipality's share of said project or undertaking and the appropriation of the last named sum, be added to and be supplementary to the appropriation provided in Section 2 above.

BE IT FURTHER RESOLVED that the above is the result of a state grant of \$4,177.54 from the Governor's Council on Alcoholism and Drug Abuse, State of New Jersey.
