

**ORDINANCE NO. 2015-9**

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ELMER,  
SALEM COUNTY, STATE OF NEW JERSEY, AMENDING CHAPTER 4  
ENTITLED "GENERAL LICENSING AND BUSINESS REGULATIONS" OF  
THE CODE OF THE BOROUGH OF ELMER**

**WHEREAS**, the Mayor and Council of the Borough of Elmer have determined that certain amendments to Chapter 4 entitled "General Licensing and Business Regulations" are necessary; and

**WHEREAS**, in all other respects Chapter 4 entitled "General Licensing and Business Regulations" shall remain in full force and effect;

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Borough of Elmer, County of Salem and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

**Section 1.**

Chapter 4 entitled "General Licensing and Business Regulations", subsection 4-9.17 entitled "Violations." shall be deleted in its entirety.

**Section 2.**

A new subsection 4-10 entitled "Enforcement" shall be added to Chapter 4 to read in its entirety as follows:

**4-10 Enforcement.**

This Chapter shall be enforced by the Police Department of the Borough of Elmer.

**Section 3.**

A new subsection 4-11 entitled "Violations and Penalties" shall be added to Chapter 4 to read in its entirety as follows:

**4-11 Violations and Penalties.**

Any person, firm or corporation who shall violate a provision of this Chapter, or fail to comply therewith, or who shall violate or fail to comply with any order or regulation made thereunder, shall severally for each and every such violation and noncompliance upon conviction thereof, be liable to the penalty state in Chapter 1, Section 1-5. In addition to the penalties herein provided, any license issued to such person violating the same shall be subject to revocation, provided, however, that notice of such proposed revocation shall be given to said licensee and a hearing given to him in accordance with the provisions of this Chapter. There shall be no refunds to a licensee upon the surrender or revocation of a license granted under this Chapter.

**Section 4.**

**Repealer.**

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

**Section 5.**

**Severability.**

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**Section 6.**

**When effective.**

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
