BE IT ORDAINED by the Mayor and Borough Council of the Borough of Elmer, County of Salem, and State of New Jersey as follows:

The foregoing Ordinance is amended by the correction of the following:

A. ADMINISTRATIVE

(13) Assistant to Municipal Clerk \$10.00 per hour  
(Not to exceed \$3,000)

2. If any section or provision of this Ordinance shall be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

3. All Ordinances, or parts of Ordinances, heretofore adopted and that are inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

4. This Ordinance shall be effective upon its final passage, adoption and publication in the manner prescribed by law.
