NOTICE TO ALL PET OWNERS – The Borough of Elmer is phasing in a new date to conduct the rabies clinic. The State of NJ requires that all rabies shots be good through November 1 of the license year. We will be having a **FREE** Rabies Clinic on **Saturday, November 5, 2011** from 10AM to 11AM at the Elmer Borough Fire Hall. (NO LICENSES WILL BE ISSUED AT THIS TIME, IT IS ONLY A FREE RABIES CLINIC). **THERE WILL BE NO CLINIC IN JANUARY, 2012.** The Pet Clinic in Elmer, will now **always** be held the FIRST SATURDAY in NOVEMBER. **If your pet rabies shot expires prior to 11/01/2012** you will need to get a new rabies shot before you can get a new pet license. Deadline for the 2012 license is 3/31/2012. After that there is a \$20 **per pet** late fee and possible additional court fines. Please check your pet's rabies information now to avoid these additional charges.

TRICK OR TREAT HOURS - Halloween Trick or Treat Hours will be held **Monday, October 31, 2011 from 4PM to 7PM.** *There is an 8PM curfew in place for Sunday and Monday night (October 30th and October 31st) for anyone under the age of 17, unless accompanied by an adult.*

SMALL CITIES HOME REHABILITATION PROGRAM – Elmer Borough and Upper Pittsgrove Township jointly received \$350,000 for housing rehabilitation work from the NJ Department of Community Affairs. The purpose of this money is to provide forgivable and deferred loans to repair homes of residents who qualify as low to moderate income. We can provide up to \$25,000 per home. If you cannot get to us during normal business hours, place your payment and letters in our secure drop box. It is located in the front of our building on the library side door entrance. It is the small box next to the Glass Door. Please remember **DO NOT PLACE CASH** in this drop box. **DON'T FORGET TO CHECK ALL DOORS** - Sometimes the front doors are locked in error during business hours. Please check both front doors and the back door (elevator entrance) before you think we are closed for business. You can also mail your payments to our office (Elmer Collections Office, PO Box 882, Elmer, NJ 08318). If you want a receipt, just enclose a self addressed stamped envelope.
