SCHEDULE B

ORDINANCE, NO. 2013-6

Handicapped Parking

1. In accordance with the provisions of N.J.S.A. 39:4-197.5 and 197.6, there is hereby established a restricted parking zone in front of the below-listed residences which are hereby determined to be occupied by a handicapped person or persons and/or all other public areas permitted by NJSA 39:197.5 that provide notice that said parking space is restricted for handicapped persons. No vehicles shall park in any such restricted area other than the handicapped person or persons occupying the designated residence, who shall have complied with the provisions of 39:4-204, et seq, which requires, among other things, that they display a handicapped placard on their motor vehicle or insure that such motor vehicle is tagged with a handicapped license plate bearing the national wheelchair symbol. Said areas are:

30 Church Street 12 State Street (First parking space located West of the handicap ramp) 133 Elmer Street

- 2. In addition, no person or vehicle shall park or be parked in any handicapped parking space that has been marked by paint on pavement in any parking lot or public street and/or has been marked by a sign restricting the parking space to handicapped parking, handicapped only, or by other restriction limiting the use of that space to those person or persons that is a handicapped person as defined by N.J.S.A. 39:4-204 unless said person has obtained a handicapped person identification card as defined by N.J.S.A. 39:4-25 and said motor vehicle has properly obtained a placard as defined by N.J.S.A. 39:4-206 or displays valid handicapped license plates as defined by N.J.S.A. 39:4-206. It shall be a presumption that any motor vehicle parking in violation of this Ordinance was so parked by its registered or titled owner.
- 3. Any person who violates this Ordinance and/or parks a vehicle in a space reserved for a handicapped individual shall be liable to a fine of \$250 for the first offense. For any subsequent offense, a fine of \$250 and a maximum of 90 days community service for each subsequent offense(s).

SCHEDULE A
